
RE: **NOTICE OF SECOND VIOLATION**

Dear Sir or Madam:

This letter is formal notice of the finding by the Illinois Department of Labor that the above named addressee's has violated the Illinois Prevailing Wage Act, 820 ILCS 130/1-12 (1994). The Department has determined that the above named addressee's violated Section 3 of the Act by failing to pay the prevailing rate of wages in Cook County to its workers performing work on the above referenced matter. The Department has determined that the total amount of wages by which the workers were underpaid was \$4,482.08. The amount represents the difference between the actual wages paid and the amount required under the Act. The assessed 20% statutory penalty amount to \$896.42. The total amount assessed against the contractor on this project was \$5,378.50.

As the failure to pay the prevailing rate of wages occurred subsequent to January 1, 1990, and within a two (2) year period of the date of your FIRST VIOLATION (copy enclosed) please consider this a NOTICE OF SECOND VIOLATION as issued by the Illinois Department of Labor pursuant to 820 ILCS 130/11a; and the Prevailing Wage Hearing Procedures, 56 Ill. Adm. Code 100 et. seq. (copies enclosed).

Because the Illinois Department of Labor has determined that the above named addressees have violated the provisions of the Illinois Prevailing Wage Act on two (2) separate occasions, the addressees are now subject to summary debarment and are barred from being awarded any contract to perform public works construction for a two (2) year period. The debarment will begin from the date of publication in the Illinois Register. The above named addressees has ten (10) working days from the date of receipt of this NOTICE OF SECOND VIOLATION to request a hearing by the Illinois Department of Labor on the alleged violations. Failure to respond within that time period shall result in automatic and immediate debarment.
